


NOTICE INVITING TENDER

The Commissionerate for Afghan Refugees Khyber Pakhtunkhwa (CAR-KP) for its project "Strengthening Social Cohesion and Social Wellbeing among Afghan Refugees and Members of Host Community (SSCSWAHC) in Khyber Pakhtunkhwa" invites tenders for Procurement of IT equipment.

1. The CAR-KP for its project "Strengthening Social Cohesion and Social Wellbeing among Afghan Refugees and Members of Host Community (SSCSWAHC) in Khyber Pakhtunkhwa" invites sealed bids under rule 36(a) "Single Stage One Envelope Procedure" of PPRA Rules 2004, from eligible bidders for procurement of IT Equipment with the following basic eligibility criteria.
 - i. Bidders should apply for the complete/whole package; incomplete/partially applied Bid will not be accepted.
 - ii. For IT equipment, only authorized dealers/manufacture shall apply.
 - iii. The Bidder must be registered with the Income / Sales Tax Department, reflected as Active Tax Payer on the list of FBR.
 - iv. The Bidder shall provide an undertaking that the Bidder has not been declared black listed by any Governmental/ Semi-Governmental Department.
 - v. Technical specifications as per required standards must be provided.
 - vi. Firm must have atleast three years of relevant experience, company profile/ Registration documents must be attached.
 - vii. Firm must have completed atleast three similar nature Projects. A list of the projects Purchase Order must be attached.
 - viii. Firm Must have minimum financial capabilities of 20 Million, Annual turnover, Audit Report & Annual Tax Returns for the last three years must be attached.

Bid Solicitation Documents containing detailed description and quantities, may be obtained from the office of Project Manager SSCSWAHC Commissionerate for Afghan Refugees Khyber Pakhtunkhwa, Phase5 Hayatabad, Peshawar, Khyber Pakhtunkhwa(In Cash Rs-1000/non-refundable) through a written application between 09:00 AM - 05:00 PM on working day (Monday to Friday) from the date of publication of this advertisement till last date for submission of bids.
3. The bidders are required to submit bid security @2% of the quoted value in shape of Call Deposit Receipt (CDR) in the name of Account titled as "SALE PROCEED A/C COMM AFGHAN".
4. The bids complete in all respect must reach the office of the undersigned latest by 1130Hrs on 15-02-2022. Bids will be opened at 1200 Hrs on the same day in the office of the undersigned in the presence of the Procurement Committee and the bidders/ representatives who may choose to attend.
